The program's target population is households (HH) with children who are literally homeless. Through RRH programs our CoC has reduced family homelessness by 72% from 2015 to 2019 and is requesting renewal funds to continue this decrease. Approximately 252 individuals in HH with children enter our homeless system yearly. Annual CoC RRH capacity is 115 persons in families. There are no longer TH programs within our CoC so RRH is the primary intervention to end family homelessness. The project will serve 3 families at a PIT and 15 families annually through scattered site private landlord apartments throughout the Lynchburg area. All referrals will come through coordinated entry. Services offered will include intake, housing barrier assessment, housing search and placement, assistance with lease signing and explanation, provision of financial rental assistance, development of a housing stabilization plan, connection to community resources, reassessment and adjustment and case closure. The duration of assistance is contingent upon a HH's needs and will vary depending on barriers and vulnerability. Services are voluntary, client-directed and trauma informed. The project uses a Housing First model and offers immediate access to housing without prerequisites. Client choice is highly considered when selecting a rental unit. MH has a robust landlord network and experience with landlord recruitment, conducting HQS inspections, lead paint inspections, environmental reviews and rent reasonableness standards. Building landlord relationships ensures opportunities to a HH with poor credit or criminal history. MH is experienced in assisting clients with obtaining mainstream benefits including SNAP, TANF, Medicaid and childcare assistance. MH partners with providers in the areas of healthcare, mental health, employment assistance, childcare, education, recovery services, disability services, housing services and social services. HH participate in the referral process to learn how to access and navigate these systems. Current average length of time households with children experience homelessness is 30 days and this success will continue. We project that 95% of referred households will attain permanent housing, 85% will remain housed a year after program exit, 75% will maintain or increase income between project entry and exit and 90% will receive mainstream benefits to which they are entitled. Client data will be entered into HMIS consistent with the CoC's data quality standard.


