Magnolia Street Supportive Housing (MSSH) provides the only dedicated chronically homeless beds within our CoC. MSSH is a single site, SRO PSH project for CH single adults housed in MH's existing LIHTC property, 409 Magnolia Street, Lynchburg, VA. MSSH uses a Housing First approach to offer housing w/o prerequisites and emphasize community integration, stable housing, recovery and individual choice. The property has 11 units, 2 shared kitchens, 3 shared lounges and 7 bathrooms. Each unit has 2 rooms; a bedroom and a living space w/ sofa, mini fridge and microwave. Amenities include laundry, computers/internet, food pantry and a clothing closet. MSSH is integrated into a neighborhood, on the busline, accessible to all city services and is within walking distance to resources and amenities. There are no external indications that the facility is a housing program for homeless persons. Tenants have full unfettered entry & exit access to the building through a fob for the external entrance and unit keys for their personal unit. Through coordinated entry, eligible applicants have a VI-SPDAT completed and the Community Case Review assigns available MSSH units to persons according to Notice CPD-16-11. Admission is low barrier (does not require service participation or screenings for substances, credit, or convictions). MSSH divides property management and supportive services into distinct roles that both support stable tenancy. Tenants have a standard lease in their name and the same tenancy rights and privileges of any private market rental. Staff review the lease with tenant at time of signing and as needed to support tenancy. Supportive services are bi-weekly, voluntary and client directed, and include benefits advocacy, employment assistance, mental health and recovery services and tenancy skill building. Housing stability is supported through service referrals, financial literacy, conflict mediation, community integration and establishing health care through local partners. The case manager is trained in harm reduction, motivational interviewing and SOAR to assist tenants with obtaining SSDI/SSI. Tenants are invited to participate in the Consumer Advisory Council to provide project input.

HMIS data is entered consistent with the CoC's data quality plan. Outcomes for tenants are 85% will remain in or exit to PH, 50% will have some form of cash income, and 85% will obtain noncash mainstream benefits. Tenants will have decreased utilization of emergency services and institutions such as jails and hospitals.



This will advise that the Greater Lynchburg Community Foundation administers an endowment fund, established January 1, 1998, specifically designated for Miriam's House. According to the original Declaration of Trust, "it is intended that the income be used and applied by the Trustees in a manner so as to assist in defraying the costs of staffing, operating and maintaining the Housing Facility, or otherwise meeting the needs of the Grantor Purpose." As of December 31, 2021, the market value of the Miriam's House Endowment Fund was \$2,223,428.37.

The Board of Directors of the Greater Lynchburg Community Foundation has a current policy of paying out 5% of the market value of its endowment funds, based on a twelve-quarter rolling average. The Greater Lynchburg Community Foundation ensures a \$91,683.00 match in 2022 under the provisions of the Miriam's House Endowed Trust.
